Sheriff Chad Kaylor attended the meeting with a list of this week's bills and claims to be signed. He reports the jail count is at 18. Sheriff Kaylor reports that a deputy for the county is going to work for City of Metropolis. He has a replacement lined up to send to the academy and will have a jailer position to fill. He briefly discussed how this could affect his budget for 2025.

Treasurer Sarah Bremer was unable to attend, but sent a list of funds totaling \$7,304,921.58.

James Mayer with Mayer Networks attended the meeting and discussed migration to Microsoft 365 Email Hosting and AUVIK.

He states the acreage reported on his tax bill is less than it should be and that he has brought it to the attention of the assessor's office multiple times. He states that twice, the assessor has left the office when he's come in to try and correct the issue. He was there again this morning, and the two employees in the office were going to look into it and call him this week. He is concerned there could be a future issue because of the incorrect acreage and just wants to pay his fair share of taxes on the land he owns. Commissioner Farmer let him know the Board of Review would be meeting in the near future and let him know how he could get on the agenda.

Ralph Steele with the Metropolis Country Club, along with 3 other members attended the meeting to discuss the service they provide to the community, including the Massac Golf Team and resulting golf scholarships some students have received over the years. They also discussed the tournaments and fundraisers they participate in and the Summer Junior Golf program. The Country Club is in need of funds for equipment and wanted to inquire if any of these items qualified for county grant funds.
