County Highway Engineer Brad Watson attended the meeting with claims to be signed.

Mr. Windhorst with So. IL Co-op attended the meeting to let the commissioners know they are in the process of correcting old easements to show the proper access for work being done. County Highway owns a small piece of property with an affected easement. Chairman Burnham signed the updated easement so that fiber cable can be installed.

Mr. Watson mentioned a grievance being filed with AFSCME that will be on the next agenda for closed session discussion. He also brought in a corrected Resolution Appropriating Funds for the Engineer's Salary correcting a typo for the yearly salary.

They have an opportunity to purchase a larger space and inquired if any of the county grant funds could be used to assist. Chairman Burnham is going to consult with the State's Attorney on the requirements to be eligible for these funds and if this would meet the requirements for any county grant assistance. Mrs. Baxter states that even if this isn't eligible, she believes there is a strong need for child care in Massac County and would like to see a county run child care center.
